







- July 17, 2021: Washington Nationals;
- Outside ballpark;
- 4 shot
- Aug 6, 2021
- Denver Coors Field
- 2 shot





Shooting Averted....



- Jan 15, 2020
- 21-year-old Ohio (INCEL) posted;
- Surveilled and planned mass shooting of women at a University in Ohio;
- Similar to 2014 Santa Barbara shooting;
- Manifesto indicated he wanted to kill out of hatred, jealousy and revenge;
- Blame women for denying him sex;
- Warrant revelated a firearm with a bump stock, pistol, ammo, and body armor.



Shooting Averted....



- July 4,2021: Chicago Navy Pier
- Window sill of room 1208;
- Rifle, scope, loaded magazines, handgun.



Shooting Averted....



- July 2021: All Star Game, Denver, CO
- After a request of a room with a balcony;
- Discovered in the room were:
- Dozens of weapons;
- Hundreds of rounds;
- Suspects said it was a Drug and gun deal?



E Shooting Averted...



- July 2021: San Francisco, CA
- Near Bayview District;
- Illegal Exhibition of speed (Street Racing)
- The armed person did not fire!



Unarmed Tactics Proven...

April 22, 2018 Antioch, TN;





Unarmed Tactics Proven...

- June 29, 2021 1:00 am Portland, OR
- Shots fired outside apartment building with handgun and AR-15;
- Resident snuck up and using a stick;
- Beat the armed suspect and disarmed him;
- He and others hogtied the suspect.


Workplace Safety Protocols/Policies...

- Do have a protocol for:
- Discipline of moderate to major infraction/violation;
- Escalating and potentially violent employee;
- Alerting others to extreme danger;
- Accounting for all employees.
- What is your policy for:
- Possession of a deadly weapon;
- Workplace Violence;
- Sexual harassment;
- Admin leave with/without pay.



16 Deadly Errors...

Any one or more could result in you not surviving an attack...





Failure to Industry to Conduct proper training...

- Other than hide and pray, what can you do to save your life?
- Truth about Table top training;
- Practical" exercises?
- All training should cover life-saving techniques;
- Bleeding control training.





Failure for Schools to conduct proper training...

- Should never include students;
- Only "Convenient" times;
- Train faculty and staff;
- Train for vulnerable times:
- Students going to and from class;
- Lunch and recess;
- Fire drills;
- End of day







Bureaucratic Paralysis...

- Management in any organization who either:
- Prohibit;
- Hinder;
- Refuse to accept ideas;
- Keeps employees from defending themselves?
- INNOVATIVE IDEA!





Lack of Situational Awareness...

- Being distracted in public;
- Take in the environment around you;
- What visual cues are you picking up or missing?
- Just look next time you're in public...





Failure to recognize Danger Signs...

- What is present that should not be there?
- Sights and sounds.
- What is missing that should be there?







Failure to notice armed person/assailant...

- Often entering facility with gun in hand;
- Wearing other items;
- Handgun or long gun;
- What actions should you take?





Mistaking gunshots for other sounds...

- Sometimes mistaken for car backfire, hammering, etc.;
- Know what gunshots sound like!





Neglecting signs of commotion...


- What are sounds of commotion;
- What do you need to see to convince you?





Improper Responses...

- Fight;
- Flight;
- Freeze.
- Which one will you do?





Improper Responses...

Don't be this guy!





E) Failure to Act...

- When potential danger is present;
- No action taken by those in control.





Failure to know your exits and environment...

- No matter where you go...
- Movie Theatre warning.





Improper Use of Cover...

- 1950's into this year;
- Temporary Cover;
- Must be able to fight;
- Look to move ASAP.









Failure to learn last resort techniques...

- Wrong tool wrong time;
- Designed to address the threat;
- Must by Practical, Easy and Effective!







Failure to have the proper equipment...

- Armed Response:
- Sufficient caliber;
- Access to holster;
- Additional ammo;
- Flashlight;
- Cell phone;
- Hands free calling;
- Identify you are the good guy!





Failure to recognize and exploit shooter's weaknesses...

Reloading, during transition or out of shooter's vision!







Unwillingness to engage the shooter...

- Shooter is known to the victim;
- Shooter's Physical appearance (age, gender, etc.)
- Mistaken belief of negotiating;
- Ability and confidence of defender.





Reluctance to use Deadly Force...

- Do you know the law?
- Do you have the ability and mentality?
- Traditional, Environmental or Improvised weapons.





Failure to prepare for the arrival of law enforcement...



- 6/25/21 Arvada,
 CO police officer ambushed and killed,
- By stander springs into action,
- Shot suspect with his concealed firearm;
- Picks up suspect's AR-15;
- Shot by responding officer who mistook him for the suspect.



Personal Survival Plan...

- 1. At least "two" avenues of evacuate;
- At least "two" places to Shelter and Hide/Fight (Your secrets)
- 3. Improvised Defensive Weapons;
- 4. Know weapons disarming techniques and being physically fit;
- 5. People <u>you can rely on</u> to help;
- Code word for family;
- Designated "Family" reunification plan (location and communication).



Shots Fired Fight Strategies...

- Run Hide Fight;
- Should actually be:
- Run Hide Ambush!



Active Shooter Defense Tactics...


- Silence all cell phones;
- Text ability to 9-1-1?
- Arm up with Improvised defensive weapons;
- Positions...
- Using concealed firearms;
- Armed Shielding...







- Once the adrenalin leaves;
- Once you relax;
- Once you are alone;
- Tape loop begins;
- Add or delete information;
- Will change information;
- Rely on who you really are!





Active Shooter Defense Techniques...

- Physical Defensive Techniques:
- 360 degree weapons disarms;
- Incapacitation techniques;
- Open area and Room Defense strategies.







Active Shooter Defense Techniques...

- Physical Defensive Techniques:
- Long gun disarms;
- Single person and team disarms;
- Ambush techniques...







Active Shooter Defense Site Assessment...

- Observations of worksite to uncover:
- Site vulnerabilities;
- Current Physical Security posture;
- Alarm system;
- Surveillance;
- Doors, windows, glass, public areas, secure areas;
- Areas for improvement;
- Written report.


